
ESCAPE – Emergency Stash of Cash Access Plan, Eh?

- o1. \$1,000 Emergency Fund
- o2. Pay off nonmortgage debt
- o3. 3-6 months in savings
- o4. Invest 15% in retirement
- 5. College funding
- o6. Pay off home early
- o7. Build Wealth and GIVE generously

- OYOU are their boss
- Annual check-up

PROBATE

- Court proceeding
- Wills don't avoid
- Triggers:
 - \circ CA = \$150K gross
 - NV & UT = \$100K net
 - •AZ = \$75K R/E, \$50K pers
- Attorney and executor fees
- **OESTATE TAXES \$5.4m**

- Living Trust revocable
- Will pour-over
- Nomination of Guardian
- DURABLE power of attorney for Financial Management
- Advance Healthcare Directive
- oHIPAA authorization
